i) The monthly payment schedule to 12th April 2024 was APPROVED with the exception of the following invoices:-

Cllr T. Tarran proposed to withhold payment subject to members receiving a breakdown of the charges from the company. APPROVED.

b) Shropshire Council Invoice 7264438 (Kings Yard Car Park Maintenance)

Cllr T. Tarran confirmed that the charges are part of the lease agreement held with Shropshire Council which Shifnal Town Council are legally obliged to pay and referred back to outstanding actions from the Estates Committee relating to the lease agreement.

Cllr K. Booker proposed that the invoice should be held until clarification can be sought on whether the charges relate to maintenance of the car park or maintaining the green area. APPROVED.

Town Clerk to seek clarification from Shropshire Council on the charges. ACTION.

c) Shropshire Council Invoice 7260558 (5 waste bins and emptying)

Cllr P. Williamson proposed to withhold payment of this invoice subject to seeking further clarification. APPROVED.

It would be illegal to display without the appropriate planning application and a criminal offence. Banners up to 1.55 sqm however would not need permission from Shropshire Council.

Clir P. Williamson proposed to proceed immediately with the most competitive quotation for the smaller sized banners that do not require planning approval and to progress with the larger sized banners as per the quotation provided to members once consent is established from Shropshire Council for the September term. APPROVED. ACTION.
