 To CONSIDER verbal update from Cllr T. Tarran following the recent meeting with Tong Parish Council, Shifnal Matters 2021 and Bruton Knowles.

Members NOTED a verbal report from Clir T. Tarran on the meeting held with Tong Parish Council and Shifnal Matters 2021. The ongoing support service provided by Bruton Knowles was considered by members.

Members RESOLVED to APPROVE Bruton Knowles preparing hearing statements for Matters 1 – 4, 21, 25 and 26. The costs of this not to exceed £5,000. (Town and Country Planning Act 1990, Budget Neighbourhood/Local Plan).

That the Committee also raise the following queries with Bruton Knowles for comment:-

The inspectors have said that they need up-to-date data on Gypsies to enable further consideration to be given to Gypsy policies. Should not a similar view be taken on Duty to Cooperate housing and employment figures for the Black Country in view of the amendments to NPPF that came into force under the previous Government (and so constitute current national policy), that changed the Duty to Cooperate requirements and more importantly, that the Black Country authority upon which the figures and Statement of Common Ground were based no longer exist.

As with gypsies, is not this data now out of date and compromised and if the Inspectors want current data on gypsies, should not they be considering revised figures related to the current situation with regard to Black Country Councils? Is this something that we should be highlighting to the Inspectors?

- ii) What advice can you give on how the Council's objections to the release of Green Belt to Safeguarding Land in Shifnal, can be brought before the Inspectors in light of the recent email correspondence with the Programme Officer? Should we still raise this as part of our statements on Matters 2 and/or 21?
- iii) In view of the Inspectors comments that omission sites cannot be considered (unless presumably as part of the consideration of alternative sites when looking at Green Belt land releases), what do you think will be considered in Matter 21; the proposed housing sites are on existing Safeguarded Land and do not involve the loss of Green Belt so there are no alternative sites to be considered. The Town Council accepted the sites and as there is little other non-Green Belt land available for housing sites, there does not seem to be much leeway for debating housing sites.
- iv) Should we refer to Harrow Estates links with Redrow and housing (as set out on their website) in regard to Matter 26 and the employment site allocation for Shifnal.

That the Committee RECOMMEND to Council approval of Bruton Knowles to participate in the Local Plan hearings subject to clarifying with Bruton Knowles the need to attend Hearing into Matter 25 as any 5 year housing supply approved under the approved Plan is likely to be superseded by Government proposed changes in housing targets.
